The program manager makes all final determinations as to student placement. 2. Summer Dance Class Levels: All Levels: Youth, general movement classes, and hip hop and classes that are not leveled; Int/Adv: Dancers that have completed a beginning level course in the style of the course they are enrolling in. 3. No make-up classes, credits, transfers or refunds for missed classes during the Summer Session. Payment is due in full to register. Registration is accepted when full-payment is received. 4 5. Enrollment is limited to 30 students per course. 6. Courses with insufficient enrollment may not be held, or they may be held as walk-in classes. Final determination will be the day before the start of each course. 7. Priority of enrollment is on a first-come, first-served basis and for those who register for the full session. Class waiting-lists are available 8. Walk-in enrollment begins the day before the start of each course providing the course has fewer than 30 people enrolled. Maximum class size of 30 dancers. Walk-in enrollment is done similar to open-class procedures. Do not use this form for walkin enrollment. 9. Issue one payment for the combined tuition. There is a \$12 service fee for any insufficient fund charge or other bank fee related to a declined bank transaction. Do not email credit card information. When registration is received, an EDGE representative will contact the parent to arrange for payment or provide additional information on how to make payment. 11 Please direct all questions and concerns to the program director on-site during the classes and other select times. 12.
